Proposed award of subsidised local bus service contracts

1. Object of report

To recommend the Committee approve the award of a number of subsidised local bus service contracts.

This paper relates to services in Argyll & Bute, East Ayrshire, East Dunbartonshire, East Renfrewshire, Glasgow City, North Ayrshire, North Lanarkshire, Renfrewshire, South Ayrshire, South Lanarkshire and West Dunbartonshire council areas.

2. Background

SPT subsidised bus services that are not provided by the commercial market but are considered socially necessary in accordance with adopted guidelines. A proportion of these contracts are due to expire in July 2021 and tenders have been sought for their renewal.

Prior to seeking replacement contracts, SPT analyse existing provision, reviewing performance data for each specified journey within each service, to align provision with actual demand. In addition, the opportunity is also taken to determine whether contracts can be amalgamated in situations where this may improve connectivity or reduce costs.

Operators wishing to bid must submit compliant tenders but optional bids are also considered, whereby the operator may submit an option which offers efficiency savings to SPT. It is also permissible for operators to package contracts where this may provide better value for money. Following a second round of tendering, direct negotiation was permitted to achieve best value for the subsidised bus budget.

3. Outline of proposals

Of the 17 individual advertised contracts, it is proposed to award 13 at this stage with a total contract value of $\pounds 2,272,628.11$ as detailed in Appendix 1. This will result in an annual increase of $\pounds 36,258.73$ to the subsidised bus budget when compared to the current annual contract value, whilst noting that contract W031F1 has now been awarded on a gross cost basis, expected to yield a net overall total contract value decrease of circa - $\pounds 30,000$.

It is also noted to the Committee that advertised contract 2835M which provides an early morning, Monday to Friday journey as service 88C, between Kilsyth and Glasgow, will not be renewed due to its acquisition on a commercial basis from July 2021 by First Glasgow. This will result in annual savings of £5,429.84 to the subsidised bus budget.

Whilst this initial set of contracts due for renewal represents an increase in costs compared with the current position, and a likely net cost saving, it should be noted that the prices submitted for the remaining contracts were considered excessive. With that in mind, those contracts not recommended will be re-tendered in an effort to achieve a more satisfactory outcome.

Copies of all timetables are available on request.

Specific details of individual contracts are attached at Appendix 1, with the current cost and revised cost shown.

In addition it should be noted that the successful bidder for contract 0914L Service 189/190 Glasgow Inner Circle, and contract W039E Service 205 Hairmyres Hospital - Blantyre - Hamilton - Torr Farm, (awarded at the Operations Committee of 29th January 2021), have subsequently withdrawn their offer. Subsequently these contracts will be required to form part of a further future tendering exercise.

4. Committee action

The Committee is recommended to agree the award of the contracts detailed in Appendix 1, noting the proposed award of contract LS022G is subject to the approval of NHSGGC for a continued 90% funding commitment.

The Committee is asked to note that previously awarded contracts 0914L and W039E will be re-tendered in due course.

5. Consequences
