There was submitted a report (issued) of 27 February 2020 by the Treasurer/Secretary updating the Committee of the Strathclyde Concessionary Travel Scheme's performance and reimbursement results for 2019/20 financial quarters 1 – 3 (April – December 2019).

After discussion and hearing from Mr Breen in answer to members' questions, the committee noted the contents of the report in particular, the impact of reported increased concessionary demand and operator reimbursement on scheme costs.

#### 6. Proposed Fare Increase and Review of Scheme

There was submitted a report (issued) of 27 February 2020 by the Treasurer/Secretary seeking Committee approval that:

- (a) an interim £0.50 increase in basic concessionary single and return fares;
- (b) ferry journeys over 10 nautical miles be charged at twice the basic concession; and
- (c) a review of the scheme, with specific focus on options to ensure its future financial sustainability

After much discussion, and the Committee confirming their agreement and support to the long-term future of the scheme, but recognising the significant affordability issues, agreed to the recommendations as detailed in the report. In addition, the Committee requested that consideration be given to how the NHS could be a partner in the scheme recognising the value the scheme makes to NHS objectives.

#### 7. Proposed Revenue Budget 2020/21

There was submitted a report (issued) of 20 February 2020 and a supplementary report tabled at the meeting by the Treasurer proposing a revenue budget for the financial year 2020/21, outlining the assumptions made in the preparation of the budget, and advising the Committee of the proposed local authority requisitions to support the Concession Scheme.

After consideration and having heard Mrs Davidson in answer to members' questions, the committee:

- (a) approved the proposed budget of up to £4.176m for financial year 2020/221, noting the requirement for approval of the proposed concessionary fares;
- **(b)** approved requisitions totalling £4.022m, a reduction of 0.44% in comparison to 2019/20; and
- (c) noted an estimated draw on reserves of £0.154m.

#### Review of Strathclyde Concessionary Travel Scheme

At the last meeting of the Strathclyde Concessionary Travel Scheme Joint Committee, a revenue budget paper highlighting increasing financial pressures being experienced by the Strathclyde Concessionary Travel Scheme (hereinafter referred to as the Scheme) was presented. It was reported that, in its present format, the Scheme is not financially sustainable in the long term without either an increase in funding from constituent local authorities, a contribution from government, amendments to the Scheme's structure or substantial increases in fares charged. In light of this, the Committee were asked to note that a review of the Scheme would be undertaken.

The Scheme complements the National Bus Scheme providing a travel option alternative, essential when no bus services exist in an area or a genuine link to the mainland and essential services for those on islands. More than 5million concession journeys are made per annum, at a cost in excess of £4.5m. This is only possible by charging a fare, but even with this the scheme is facing real challenges. The Scheme takes in the entirety of the former Strathclyde area, meaning travel discounts are also offered to people living in more remote rural and islands communities such as Coll, Tiree, Colonsay, Islay, and Jura and for whom longer journeys and travel to the mainland is often a necessity.

On behalf of all the councils in the West of Scotland, all options are now being considered by the Joint Committee, including significant fare increases and simply stopping the Scheme altogether. I know many other authorities have simply closed schemes to save money, but to do this will have significant impacts on more than 500,000 card holders who rely on the Scheme to access services including healthcare.

The purpose of my letter is simple – I am writing to advise you of the current situation and to seek your support in financial terms to ensure this essential travel scheme can continue. Relatively small sums of support would make a significant difference in this area.

Dear Martin

Thank you for your letter of 4 December 2019, seeking additional financial support for the Strathclyde Concessionary Travel Scheme.

The Scottish Government consistently faces calls from a wide range stakeholders to expand the National Concessionary Travel Scheme for Older and Disabled People in Scotland to more people. As you are aware we have committed to maintaining the current scheme and eligibility. This year we are providing more than £210 million in reimbursement to bus operators for journeys made under the national scheme. We also provide local authorities with block grant to prioritise spend to the best effect to support local needs, meaning that funding the Strathclyde Scheme is entirely at their discretion.

I understand that budgets are constrained and more is being expected from public services in the face of poverty and inequality. We have committed, with the Scottish Youth Parliament, to take forward a review of extending discounts on public transport to those under 26. This review also seeks to address two other commitments, a cost and benefits appraisal of extending free bus travel to those under 26 following a parliamentary debate on free bus travel; and the transport commitment under the Child Poverty Delivery plan to explore how all areas of transport, including travel concession schemes, can best support the delivery of the child poverty reduction targets.

Scottish Ministers, special advisers and the Permanent Secretary are covered by the terms of the Lobbying (Scotland) Act 2016. See www.lobbying.scot







I am committed to exploring ways of making transport more affordable and available to those who need it most. However, Scottish Government resources have been constrained by a decade of UK austerity. Our discretionary resource budget for 2020-21 will be 2.8% lower in real terms than it was in 2010 (even including the effect of the UK Spending Round). Against this backdrop, the Scottish Government is not in a position to provide further financial assistance to the Strathclyde Concessionary Travel Scheme.
