Covid-19 Crisis – Transport Progress Update: Presentation

Report by Chief Executive

1. Object of report

To advise the Partnership of the content of a presentation to be given to the current meeting in relation to the Covid-19 crisis and transport in the west of Scotland.

2. Background

The impacts of the Covid-19 public health emergency continue to dominate activity across many sectors, including transport. Members have been updated on progress via various reports to the Partnership and Committees, including most recently to the Operations¹ and Strategy and Programmes² Committees. Given the fluid and evolving nature of the impact of the crisis, and responses to it, the presentation will give an up-to-date position on a range of matters, which relate to the work of SPT, Councils and other partners in the west of Scotland.

3. Outline of Proposals

- 3.1 The presentation will cover the following key areas:
 - SPT's ongoing response, including business continuity arrangements, the Subway, supported bus services including MyBus, bus stations, school transport, community transport, travel card unit, funding, Bus Partnership and communications and engagement;
 - The Scottish Government/Transport Scotland response, including bus service enhancement support, the Bus Priority Rapid Deployment Fund (BPRDF), Bus Partnership Fund, Spaces for People, COP26, Strategic Transport Projects Review 2, National Planning Framework 4, and ongoing liaison arrangements;
 - Transport Transition Plan (TTP) National and Regional Advisory Groups, including progress on the Glasgow City Region TTP, progress with Ayrshire and Argyll & Bute councils, bid to BPRDF, and Interim Regional Spatial Strategy; and
 - The preparation of the new Regional Transport Strategy (RTS), including updating the RTS Key Issues.
