#### 4. 2017/18 Annual Audit Report

There was submitted a report (issued) of 23 October 2018 by the Treasurer/Secretary providing the Committee with the finalised 2017/18 Annual Audit Report by Scott-Moncrieff.

There was submitted a report (issued) of 23 October 2018 by the Treasurer/Secretary, providing the Committee with the finalised and audited Strathclyde Concessionary Travel Scheme Joint Committee (SCTSJC) financial statements which had been considered by SPTs Audit & Standards Committee as previously agreed.

of the Strathclyde Concessionary Travel Scheme ('the Scheme') for financial year-end 2017/18 and for financial quarters 1 and 2 of 2018/19 and informing members of the following:

- (a) monitoring of the Scheme during 2017/18 has highlighted an overall patronage increase of 180,000 compared with levels observed during 2016/17;
- (b) the 6-week suspension period on Subway that occurred in Q2 of 2016/17, has contributed to the significant patronage increases recorded during 2017/18;
- (c) patronage results for 2017/18 highlight that demand for concessionary travel remained strong, and for the first time, in excess of 5million concessionary journeys per annum were recorded:
- (d) monitoring of the Scheme during the first two quarters of 2018/19 has highlighted a slight increase in patronage of 1% in both quarters. This equates to an additional 30,000 journeys made in each quarter;
- (e) reimbursement costs during the first two quarters of 2018/19 have remained at the previous year's levels;
- (f) the Scheme fare increases applied in 2017 and 2018 have helped manage Scheme costs;
- (g) that Road Equivalent Tariff (RET) fares on CalMac routes increased in March 2018 and were the first fare increases in 3 years. Members were also reminded of annual fare increases on rail, with peak fares due to increase by 3.2% and off-peak fares by 2.2% in January 2019. Such increases to operators' standard fares are likely to result in increased reimbursement costs to the Scheme. Taking this into account, officers will continue to consider ways in which the costs of the Scheme can be managed within budget projections; and
- (h) to note the announcement by Scottish Government to keep the age eligibility for national entitlement concessionary travel in Scotland at 60.

#### 7. Revenue Monitoring Report as at 13 October 2018, Period 7
