# Minute of the meeting of the Strathclyde Partnership for Transport's Personnel Appeals Sub-Committee held in Consort House, Glasgow, on 25 September 2008

## 1. Exclusion of press and public

The Sub-Committee resolved in terms of Section 50A(4) of the Local Government (Scotland) Act 1973 to exclude the press and public from the meeting, as exempt information, as defined in paragraph 1 of Part 1 of Schedule 7A, was likely to be disclosed.

#### 3. Decision

The Sub-Committee resumed consideration of both appeals and having heard and considered carefully all the documents and evidence, agreed

- (1) that the grounds of both appeals had been substantiated in part and accordingly that the appeals be upheld;
- (2) that both appellants had been found nevertheless to be in breach of SPT's disciplinary policy by their own admission;
- (3) to rescind the decision to dismiss both appellants and substitute this with the following:
  - that both appellants be suspended from post without pay from 18 August 2008 for a period of 6 weeks;
  - that both appellants be issued with a final written warning to be kept on file for a period of one year;
  - that any further inappropriate behaviour should result in dismissal; and
  - that both appellants undertake a course in anger management and that appellant SP03 also undertake a course in supervisory skills.

Thereafter, both the appellants, together with their representatives, were re-admitted to the meeting independently and advised of the Sub-Committee's decision.
