9. Subway Modernisation: Progress Update

There was submitted and noted a report (issued) of 28 May 2015 by the Assistant Chief Executive (Operations)

- (1) providing information on the overall progress made on the Subway modernisation project since the last update to the Partnership in December 2014, particularly in relation to
 - (a) the station refurbishment works which were progressing well with construction started at Govan and Buchanan Street stations;
 - (b) the implementation of new escalators which was progressing well with escalators recently installed at Cowcaddens (down);
 - (c) progress on the infrastructure workstreams which were at various stages of the project lifecycle e.g. design, implementation and testing; and
 - (d) the new rolling stock, signalling and control systems procurement which was now entering the final phase, with a target date of October 2015 to bring forward a recommendation for the award of contract; and
- (2) explaining that, as part of the wider programme of activities for Subway modernisation, the overall programme was within overall budget and funding.

10. South Glasgow Hospitals – SPT Support for NHSGGC transport arrangements - update Click here to view report

There was submitted a report (issued) of 4 June 2015 by the Assistant Chief Executive (Operations)

- (1) reminding members that SPT continued to work in support of NHS Greater Glasgow and Clyde (NHSGGC) and Glasgow City Council (GCC) regarding transport for the new South Glasgow University Hospitals and Royal Hospital for Sick Children (SGUH) complex, the phased opening of which had begun in late April 2015;
- (2) providing an update on current SPT activity regarding support for the provision of transport for the SGUH complex including funding, bus services and infrastructure, Fastlink, Subway modernisation, Hospital Evening Visitor Service, Integrated Transport Hub and Travel Demand Management; and

(3) intimating

- (a) that, since the previous update, the SGUH complex had seen its first intake of patients together with the transfer of more key services from other hospitals, including most services (including Accident and Emergency) from the Western Infirmary and Royal Hospital for Sick Children, and all services from the Victoria Infirmary and Mansionhouse Unit;
- (b) that work had begun in late May on the refurbishment of Govan Interchange which would deliver a revamped and fully integrated interchange covering Subway, bus and Fastlink and would play a key role for those accessing the SGUH complex; and
- (c) that SPT continued to provide support to NHSGGC and GCC for transport provision for the complex and continued to seek progress on many issues to ensure that appropriate transport provision was put in place.

11. Fibre Licence Agreement

After consideration of a report (issued) of 4 June 2015 by the Assistant Chief Executive (Business Support) on the requirement to lay and maintain a fibre cable through Queen Street Station to connect Buchanan Subway Station to Buchanan Bus Station, the Partnership agreed

- (1) that SPT enter into a 20 year licence agreement with Network Rail for this purpose at a rent of £2,000 per annum with no rent reviews; and
- (2) that authority to agree the terms of the licence, including appropriate termination provisions, be delegated to the Assistant Chief Executive (Business Support) in consultation with the Senior Legal Advisor.
