4. Proposed award of temporary local bus contracts 0902T and 3699T2

There was submitted a report (issued) of 21 October 2008 by the Assistant Chief Executive (Operations)

- (1) outlining tenders received for the award of temporary subsidised local bus service contracts 0902T Rutherglen/Bankhead – Glasgow (service 7) and 3699T2 Govan – Victoria Hospital (service 121) in order to secure the continued operation of socially necessary journeys until longer term contracts could be awarded; and
- (2) recommending the award of the following temporary contracts which would operate from 7 November 2008 until 31 January 2009:-
 - (a) contract 0902T Rutherglen/Bankhead Glasgow (service 7) to First Glasgow (No 1) Ltd at a cost of £387 per week; and
 - (b) contract 3699T2 Govan Victoria Hospital (service 121) to Arriva Serving Scotland at a cost of £1,127.59 per week.

After discussion, the committee

- (i) agreed to the recommendations; and
- (ii) noted that tenders would be invited for longer term contracts for consideration at a future Operations Committee meeting.

5. Proposed change to subsidised local bus service – contract 4945F
