Drivers and/or attendants who have been deemed suitable for use on Inverclyde Council school transport contracts via the PVG Scheme but who have transferred from one contractor to another. Provision of information to SPT to enable drivers/attendants to be used on school transport contracts but ONLY those contracts funded by the same Council(s) who have already given them clearance and in so doing avoid the need for a re-application for a new PVG Scheme Record.
