

Register of Transport Operators

Transport operators who intend to tender for SPT contract work require to have a SPT Operator Reference number. Operators of local registered services will also need to have a SPT Operator Reference number as this assists in processing the local service registrations. Transport operators should apply for their reference number **before** submitting any local service registrations or contract tenders.

The information sought in this form will provide us with the basic information that we need so that we are able to contact you if we have any queries relating to your registrations or tender submissions and that we have the correct licence and operating centre details.

Upon receipt of the correctly completed form SPT will place you on our Register of Transport Operators and will write to you with your SPT Operator Reference Number. This number should be quoted in all correspondence with SPT and must be quoted in any tenders you submit.

For those transport operators who are interested in tendering for contracts, SPT advertises all tenders via the Public Contracts Scotland website at www.publiccontractsscotland.gov.uk. This is a secure website that is free to use and you should register at the website in order to access SPT tender information. You can sign up to receive e-mail alerts whenever SPT advertises contracts that tenders are being sought.

Update of information

This form can also be used by operators who have already registered with SPT and who have an Operator Reference Number to update their details, for example, change of address, telephone numbers or e-mail address. <u>All changes to contact details must be notified to SPT using this form, which must be signed.</u>

Before the award of any contract, as part of the tender evaluation process, SPT will require evidence that tenderers have both suitable insurance and any licence(s) required. It is a condition of contract that operators allow SPT officials to inspect their vehicles, maintenance facilities, including maintenance records and operation of contracts. In addition, **before commencing** any Regulated Work, as defined by the Protection of Vulnerable Groups (Scotland) Act 2007, all drivers/attendants will be required to be vetted by SPT on behalf of the relevant Council(s) through Disclosure Scotland to determine their suitability.

SPT may require to view copies of licences and certificates of insurance relevant to your local registered services in order to process your application for a SPT Operator Reference number.

In order to process your application for a SPT Operator Reference number, it will also be necessary for SPT to view, use and, in some circumstances, share the personal information which you provide on this form and such licences and certificates of insurance as you may provide to SPT, with the appropriate authorities within SPT's area and/or other relevant bodies and/or as permitted or required by law.

Irrespective of whether SPT allocates you a SPT Operator Reference number in accordance with this application, SPT may also share the personal information provided on this form and such licences and/or certificates of insurance as you may provide, with appropriate authorities and/or other relevant bodies as permitted or required by law.
