6. Proposed Revenue Budget 2023/2024

There was submitted a report (issued) of 28 February 2023 by the Treasurer presenting to the Committee for approval a proposed revenue budget for the financial year 2023/2024, outlining the assumptions made in the preparation of the budget and advising the Committee of the proposed local authority requisitions to support the Strathclyde Concession Travel Scheme ("the Scheme"). The outline of the 2024/2025 budget was also presented for noting at this stage.

After hearing from Mr Paul and Mr Wylie in response to members' questions, the Committee approved:

- (i) the proposed budget of £4.138m for financial year 2023/2024;
- (ii) requisitions totalling £4.138m, a 1.95% increase compared to 2022/2023; and
- (iii) a pause in the implementation of the new fares structure until April 2024, when the matter will be reviewed again as part of the future budget planning exercise.
