**Minute of the meeting of Strathclyde Partnership for Transport's Operations Committee held in 131 St Vincent Street, Glasgow, on 10 March 2017**

**Present** Councillors Kaye Harmon (Chair), Bill Grant, Gerald Leonard, Alan Moir, Bobby McDill, Robert G MacIntyre and Hamish Stewart and appointed members Gregory Beecroft and Graham Johnston.

**1. Apologies**

Apologies were submitted from Councillors Malcolm Balfour, Jonathan Findlay, Denis McKenna, Lawrence O'Neill and David Wilson.

**2. Declaration of interest in terms of the Ethical Standards in Public Life etc (Scotland) Act 2000**

Councillor Moir declared an interest in respect of his employment with ScotRail in relation to a possible overlap with Network Rail discussions.

**3. Minute of previous meeting**

The minute of the meeting of 20 January 2017 was submitted and approved as a correct record.

**4. Monitoring report on public transport services in the SPT area**

There was submitted a report (issued) of 2 March 2017 by the Assistant Chief Executive (Operations)

- (1) informing the committee of the latest trends in the number of passengers carried and the reliability of services directly operated and supported by the Partnership and on ScotRail services in the SPT area (tabled at the meeting); and
- (2) providing information on the current status of SPT's bus action plan for the continuing improvement of bus service delivery within the region, regulating and fleet profile statistics and details of subsidised local bus service vehicle inspections.

After discussion and having heard Messrs Stewart, Hoskins and Scott in further explanation and in answer to members' questions, the committee noted the terms of the report.

**5. Subsidised local bus service contract recommendations – financial implications**

There was submitted a report (issued) of 23 February 2017 by the Assistant Chief Executive (Business Support) advising the committee of the financial implications of members' possible decisions relating to further items on the agenda.

**6. Proposed renewal of subsidised local bus service contracts**

There was submitted a report (issued) of 21 February 2017 by the Assistant Chief Executive (Operations)

- (1) informing members of tenders received for the renewal of local subsidised bus service contracts;
- (2) providing information on the various options contained in the tender documents; and
- (3) recommending the award of appropriate contracts.

**8. Management, Development, Selling and Maintenance of SPT Advertising Space – Proposed award of contract**

There was submitted and approved a report (amended version tabled at the meeting) of 9 March 2017 by the Assistant Chief Executive (Operations)

- (1) reminding members
  - (a) that, to support the cost of operating the Glasgow Subway and Bus operations, SPT had determined that it required to sell the advertising and promotional spaces that it had available on its trains, stations and bus facilities; and
  - (b) that, in particular, the Subway was a very attractive advertising proposition with passengers exposed to local and national content for their full journey time and in an environment conducive to influencing the public in their leisure and buying habits;
- (2) intimating
  - (a) that over recent years, SPT had had significant influence in stimulating the digital advertising arena in Glasgow, with the launch of the digital screens in its stations;
  - (b) that as part of the Subway Modernisation Programme, digital advertising had been implemented as a positive alternative to counter balance the potential of lost sales where traditional advertising sites were temporarily removed during the station refurbishment and over a lengthy period; and
  - (c) that over the five years of the current advertising contract, SPT had been paid a minimum guaranteed sum of £4.25m, together with a further £500,297 (net of disruption costs) as a result of additional digital advertising screens and the significant collaborative exercise of creating alternative sites across Subway and Bus Stations during Subway Station refurbishments. In the current financial climate, it was essential that SPT maintained strong focus on continuing to protect and develop these revenue generating opportunities;
- (3) explaining that the current advertising contract had been awarded to Primesight in April 2012 for an initial period of three years, with a subsequent two year extension that would expire at the end of March 2017;
- (4) informing members that a tender exercise had taken place for the management, development, selling and maintenance of advertising across SPT's estate and had been separated into 2 lots, viz. -  
  
Lot 1: Subway stations, train car advertising and bus stations; and  
  
Lot 2: roadside advertising;
- (5) providing information on the results of the tender exercise; and
- (6) recommending that the Committee agree to the award of contracts to
  - (a) Exterion Media for Lot 1, who had offered a guaranteed sum for five years of £6,700,000, together with a further potential share dependant on actual contract advertising sales; and

- (b) Forrest Outdoor Media for Lot 2, who had offered a guaranteed sum for ten years of £448,938 for each developed site, commencing immediately with 5 confirmed sites.

After consideration and having heard Mr Stewart in amplification of the report and in answer to members' questions, the committee

- (i) approved the recommendation at (6) above; and
- (ii) noted that the award of each Lot within the contract was subject to the satisfaction of the requirements of the mandatory standstill period for EU advertised public sector contracts.

**9. Request for subsidised local bus services**

There was submitted a report (issued) of 14 February 2017 by the Assistant Chief Executive (Operations) advising members of various requests for the provision of subsidised local bus services.

After consideration, the committee

- (1) agreed not to take any further action in respect of the local subsidised bus service requests at paragraphs (a) (c) and (d); and
- (2) agreed as follows in respect of the undernoted requests:-

To provide a bus service to the Moorfield Housing Estate, Kilmarnock  (report item b)	Investigate opportunities within existing subsidised and commercial public transport network
To fund a direct bus service between Bellshill Town Centre and Maxim Office Park/Eurocentral  (report item e)	Investigate opportunities within existing subsidised and commercial public transport network, whilst encouraging discussion with Maxim Office Park in relation to any future development proposals.

**10. Valedictory**

As this was the last Operations committee meeting before the local elections, the Chair thanked all members and staff for their help and support over the past five years.
