There was submitted a report (issued) of 26 August 2008 by the Assistant Chief Executive (Business Support),

- (1) reminding members that, in accordance with the Chartered Institute of Public Finance and Accountancy "Treasury Management in Public Services Code" and SPT's Financial Regulations, an annual report required to be produced to present an overview of treasury activities undertaken in the previous financial year;
- (2) summarising the Treasury Management performance for the financial year 2007/08 which covered
 - SPT's current treasury position;
 - the economy in 2007/08;
 - borrowing and investment rates in 2007/08;
 - the borrowing outturn for 2007/08;
 - compliance with treasury limits and prudential indicators;
 - investment strategy for 2007/08;
 - investment outturn for 2007/08 and
 - debt re-scheduling;
- (3) appending SPT's Prudential Indicators; and
- (4) intimating that during 2007/08, debt repayments were in line with plans actively to reduce debt where possible and that interest earned had shown a significant increase on 2006/07 which was a result of more favourable rates in the course of the year, as well as continued effective treasury management.

After considerable discussion and having heard Mr Wylie and Mrs Davidson in further explanation and in answer to members' questions, the committee

- (a) noted the terms of the report; and
- (b) agreed that a report on SPT's long term strategy for debt-repayment be submitted to a future meeting of the committee.

With reference to the minute of 27 June 2008 (page 1, paragraph 1) when the committee had noted that SPT's redraft of the Regional Transport Strategy (RTS) 2008 – 2021, which took account of the comments made by the Cabinet Minister for Finance and Sustainable Transport, had been approved, there was submitted a report (issued) of 2 September 2008 by the Assistant Chief Executive (Business Support),

(1) reminding members

- (a) that the Minister had confirmed that SPT was required to develop a Delivery Plan to comply with Scottish Government Guidance; and
- (b) that a consultative draft Delivery Plan had been issued to constituent councils in June 2008 comprising all projects and interventions which had been identified to meet the RTS and was sourced from:-
 - the draft RTS approved by the Partnership in March 2007;
 - related RTS Action Plans (e.g. for bus, freight and park and ride etc;
 - the current Capital Plan; and
 - specific projects included within Transport Outcome Reports prepared by SPT as a contribution to constituent councils' emerging Single Outcome Agreements (SOAs);

(2) advising members

- (a) that since SPT already had Capital Plan and Business Plan processes, the key purpose of the Delivery Plan Guidance Framework was to steer these future plans towards the approved RTS and, in particular, to sharpen SPT's focus on the delivery of the key strategic priorities for the next 5 years; and
- (b) that Scottish Government guidance also required SPT to set out its performance annually against the RTS and Delivery Plan;
- (3) enclosing as appendices to the report
 - (a) a Delivery Plan Guidance Framework which would be used as a tool to guide the development of SPT's Capital and Business Plans thus aligning each to the objectives and strategic priorities of the RTS; and
 - (b) a summary of the key comments from the consultation responses;
- explaining that the delivery plan guidance would be used to steer the Capital and Business Plans in order that they comprised projects and interventions which:-
 - related to the 17 strategic priorities of the RTS, the RTS Action Plans, and primarily the key strategic priorities;
 - were the most effective in addressing SPT's regional remit;
 - were most effective in meeting the RTS objectives and the strategy outcomes of "improved connectivity, access for all, reduced emissions and attractive, seamless reliable travel";
 - prioritised projects which were safety critical, maintained an operational asset or were needed to meet legislative requirements;
 - supported constituent councils' Single Outcome Agreements and had been identified in SPT Transport Outcome Reports for each Council; and

- guided and worked towards the allocation of SPT resources on the basis that 70% of resources would go to the key strategic priorities and 30% to the remainder over a 5 year period, as previously agreed; and
- (5) recommending that the committee
 - (i) approve
 - (a) the Delivery Plan Framework; and
 - (b) the concept of SPT's Delivery Plan comprising the Framework, the Capital Plan and the Business Plan; and
 - (ii) note that the draft capital and business plans consistent with the framework would be brought forward to a future committee for approval.
