After hearing from Mr Breen and Mr Wylie, members were advised that appropriate transport operators would shortly be written to regarding the new fare structure, and officers were aware of the importance of communication to concession card scheme users.

The Chair also advised that he had been made aware of a possible discrepancy concerning the impact that planned concessionary fares changes will have on Cowal peninsula ferry services as a result of Road Equivalent Tariff (RET) pricing not being applied to these routes, and that officers will review the issue in detail, engaging with relevant stakeholders, and feedback to the first meeting of the Committee in 2022. Thereafter, the Committee noted the content of the report.
