 - (ii) contract 4980G (service 14) to McGill's Buses at a cost of £76,400 for the contract period from 17 July 2016 to 14 July 2018;
 - (iii) contract LS074N (services 245,310) to McGill's Buses at a cost of £1,111,835 for the contract period from 17 July 2016 to 10 July 2021;
 - (iv) contract LS076M (service 312) to McGill's Buses at a cost of £99,106 for the contract period from 17 July 2016 to 14 July 2018;
 - (v) contract LS083G (service 165) to McGill's Buses at a cost of £110,000 for the contract period from 17 July 2016 to 14 July 2018;
 - (vi) contract W038E (service 70) to Gibson Direct at a cost of £61,551 for the contract period from 17 July 2016 to 13 July 2019;

Contract W100T Cumnock – Kilmarnock (service X76)	Contract extended from 3 April to 16 July 2016 after which date the journey would be incorporated within the substantive contract for the route (additional cost of £51 per week)

Future progress of the works would require supplementary alterations to the route of these services until completion of the project in August 2017 (no additional cost)
Contract W022C Harthill/Torbothie - Shotts - Wishaw General Hospital/Netherton Industrial Estate/ Ravenscraig Sports Centre (services 365/366/367)	Alteration to route of service 366 for an estimated period of 6 months with effect from 4 January 2016 due to planned road closure to facilitate railway bridge repair works (additional cost of £39 per week for the duration of the works)
Contract 4833K Hairmyres Station Interlink (service 399)	Alteration to timetable of service with effect from 3 April 2016 to improve connections with peak train arrival and departures at Hairmyres Rail Station (no additional cost)
Contract 2876G1 Cumbernauld Local (service 343) Cumbernauld - Condorrat – Seafar (service 343A)	Alteration to route and timetable of service 343A with effect from 17 January 2016 following changes to the commercial bus network and analysis of passenger usage (reduction in cost of £139 per week)
Contract 4801S Carnwath - Lanark – Braehead (service 137)	Alteration to timetable of service with effect from 3 April 2016 to address reliability issues stemming from excessive delays at Cleghorn level crossing near Lanark (no additional cost)
