Report by Treasurer

1. Object of Report

The object of this report is to update the Joint Committee on the performance of the Travel Card Unit (TCU) and provide updates on any other activities affecting the Travel Card Unit.

2. Background

SPT's Travel Card Unit, based at Buchanan Bus Station (BBS), is responsible for administering the National Entitlement Card on behalf of the 12 SCTS-area local authorities. Contact with cardholders and applicants from the 12 local authorities takes the form of email, postal correspondence, faxes, telephone calls and face-to-face enquiries at the Concessionary Travel Booth in BBS.


3. Cards in Circulation

As at February 2018 there were 558,754 valid cards in circulation within the SCTS area. This represents an overall increase of 3.9% in the preceding 12 months. Cards issued to over-60s make up the majority of this increase. Cardholders with disabilities increased 2.4% to 86,000 within the same period. The breakdown of card types by type and by Local Authority can be found in Appendix A.

4. TCU Performance


4.1 Call Numbers

Call numbers up to Period 11 (3 February 2018) are 78,633, which is 10.75% down on the 2016/17 figures, but the 2016/17 statistics included the card replacement programme, which caused unusually high volumes towards the end of 2016. Against 2015/16, call numbers increased 9.2% to P11.




4.2 Processing of First Time Applications

Applications for new cards using the NCT001 form (for those with a disability) are broadly in line with previous years, totalling almost 6,700 to P11, compared with 6,500 and 6,900 in 15/16 and 16/17 respectively:



4.3 Renewal Reminders Issued

31,167 reminder letters were sent to customers whose cards were due to expire in 2017/18, an increase of 4.6% on last year.



5. Developments within Travel Card Unit

Work to review working practices within the Travel Card Unit continues, with focus on efficiency of processes and relevance of reporting metrics.

As organisations prepare for the introduction of GDPR regulations in May 2018, SPT is engaged with the National Entitlement Card Programme Office (NECPO) and our local authority partners to ensure compliance.

6. Committee Action

The Committee is recommended to note the progress of the Travel Card Unit in supporting concession travel on behalf of the 12 councils in the Scheme area and the work being undertaken as part of their card issue.
