#### 4. Updated Financial Forecast for financial year 2020/21 as at the end of Period 10

There was submitted a report (issued) of 3 February 2021 by the Assistant Chief Executive providing members with an updated financial forecast for the current financial year, stating the assumptions made regarding expenditure and income levels, including the income loss grant from Transport Scotland and to advise of ongoing discussions with Transport Scotland regarding continued financial support.

After having heard from Mr Wylie in answer to members' questions, the Committee considered the report and noted:

- (i) the forecast outturn at this stage and the level of expenditure required to assist with the deficit; and
- (ii) that discussions continue with Transport Scotland over continued financial support for the current financial year to address the projected deficit.

#### 5. Revenue Budget for 2021/22 – Update

There was submitted a report (issued) of 3 February 2021 by the Assistant Chief Executive providing members with an update on the preparations to present a balanced revenue budget for 2021/22 to the 12 March 2021 Partnership, and asked the members to consider the risks and challenges being faced at this stage. The report sought to highlight the assumptions being made in the preparation of the budget, proposals for fees and charges and the draft proposed local authority requisition. In addition, members were asked to note the review of the reserves policy and recommend this to the Partnership.

After considerable discussion principally relating to the significant continuing financial impact of Covid-19 on SPT's income generating base, notwithstanding that the final Local Government Settlement remains outstanding and having heard from Mrs Davidson and Mr Maclennan in answer to members' questions, the Committee:

- (i) considered the draft revenue budget and the assumptions being made as detailed in the report, including the proposed draft local authority requisition levels;
- (ii) noted that further work continued to minimise the uncertainty of assumptions;
- (iii) agreed that a balanced budget would be presented to 12 March 2021 Partnership for approval;
- (iv) noted the current and projected reserve balances as detailed in section 5; and
- (v) recommended that the Partnership approve the update to the Reserves Policy.

- (ii) agreed to Grant Fund or to vary existing Grant Fund letters to the Local Authorities or other bodies for those awards up to the value of £200,000 and authorise the Assistant Chief Executive to complete the award letters;
- (iii) agreed to recommend to the Partnership meeting of 12 March 2021 approval to Grant Fund or to vary existing Grant Fund letters to the Local Authorities or other bodies for those awards over a cumulative value of £200,000;
- (iv) noted the financial performance of the 2020/21 capital programme as at Period 10; and
- (v) noted that further work to quantify and manage risk, advance savings and re-phase existing projects is being undertaken to balance spend against budget.
