# Minute of the meeting of the Strathclyde Partnership for Transport held in the Lewis Room, 131 St Vincent Street, Glasgow, on 21 June 2019

#### 8. Regional Transport Strategy – progress update

There was submitted a report (issued) of 22 May 2019 by the Assistant Chief Executive providing a progress update on the preparation of the new Regional Transport Strategy (RTS) for the Strathclyde Partnership area and highlighting external factors that are influencing the development of the RTS, including the National Transport Strategy (NTS).

After discussion and hearing from Mr Kiloh in response to members' questions, the Partnership:

- (i) noted the contents of the report and requested that the RTS work be extended to include research on how other European Cities fund public transport;
- (ii) sought clarity again on the status of the recent Glasgow City Council Connectivity Commission Report; and
- (iii) agreed that a report on how SPT was responding to the climate change emergencies declared by other stakeholders would be presented to a future Committee.

# 9. Workplace Parking Levy – proposed amendment to Transport (Scotland) Bill – SPT response

There was submitted a report (issued) of 21 May 2019 by the Assistant Chief Executive recommending the approval of SPT's draft response to a request from the Scottish Parliament's Rural Economy & Connectivity (REC) Committee for a written submission regarding a proposed amendment to the Transport (Scotland) Bill in relation to a Workplace Parking Levy. SPT's response was submitted by officers to the REC Committee as a draft response, subject to Partnership approval, prior to the deadline of 22 May 2019.

The Partnership sought clarity from Mr Kiloh, specifically in relation to the proposed wording of section 2 of the response "Structure of the WPL Framework", which stated:

"While we believe that, in most circumstances, it would not be equitable for businesses to pass the costs for the WPL onto individual employees, ..."

and a request from Councillor Anna Richardson that it be removed from the final response.

After discussion, Councillor Graeme Brooks, seconded by Councillor Lee Lyons, moved a motion that the drafted sentence should be retained in the SPT response.

In response, Councillor Anna Richardson, seconded by appointed member Ann Faulds, moved a motion that stated that the sentence should be removed, and following the Chair's intervention, all parties agreed to continue discussions to allow a consensus to be reached.

Thereafter, following significant discussion with regards to the specific wording and hearing further from Mr Kiloh in response to members' questions, the Partnership reached consensus on the following wording:

"SPT would support that if employers do charge, then employers should take into account the affordability to employees when deciding on an employee's contribution towards the Workplace Parking Levy. It must also be recognised that some workers will have no alternative, in the form of public transport, and therefore this may be or could be considered to be a tax."

The Partnership agreed to the content of the SPT response within appendix 1 of the report, subject to change of text as stated above and other changes requested at the meeting.

## 10. North Lanarkshire Council Transport Issues – Member Officer Working Group Key Outcomes
