Minute of the meeting of Strathclyde Partnership for Transport's Operations Committee held in 131 St Vincent Street, Glasgow, on 24 June 2016

1. Apologies

Apologies were submitted by Councillors Malcolm Balfour, Duncan Cumming (substitute), Bill Grant, Alan Moir, Bobby McDill and Lawrence O'Neill.

2. Declaration of interest in terms of the Ethical Standards in Public Life etc (Scotland) Act 2000

Councillor Stewart declared an interest in respect of Item 12(h) in his role as Director of The Rural Development Trust Ltd.

3. Minute of previous meeting

The minute of the meeting of 13 May 2016 was submitted and approved as a correct record.

Arising from the minute in relation to page 8, paragraph 10(2), Mr Stewart advised members that the Transport Impact Assessment referred to in the minute, had acknowledged that Ayrshire Central Hospital Woodland View development was well connected with public transport.

4. Monitoring report on public transport services in the SPT area

There was submitted and noted a report (issued) of 14 June 2016 by the Assistant Chief Executive (Operations)

- (1) informing the committee of the latest trends in the number of passengers carried and the reliability of services directly operated and supported by the Partnership and on ScotRail services in the SPT area; and
- (2) providing information on the current status of SPT's bus action plan for the continuing improvement of bus service delivery within the region, regulating and fleet profile statistics and details of subsidised local bus service vehicle inspections.

6. Temporary contract awarded

- (1) advising members of a temporary contract procured and awarded, under delegated authority, on behalf of North Lanarkshire Council; and
- (2) informing members that the contract had been developed via The Smarter Choices, Smarter Places initiative, aimed at encouraging sustainable alternatives to car travel.

7. Proposed renewal of subsidised local bus service contracts

There was submitted a report (issued) of 2 June 2016 by the Assistant Chief Executive (Operations)

- (1) informing members of tenders received for the renewal of two local subsidised bus services;
- (2) providing information on the various options contained in the tender documents; and
- (3) recommending the award of appropriate contracts.

8. Proposed award of a subsidised local bus service contract

There was submitted a report (issued) of 26 May 2016 by the Assistant Chief Executive (Operations)

- (1) informing members of the tenders received for the renewal of a local subsidised bus service contract; and
- (2) recommending the award of an appropriate contract.

Following discussion, the committee

- (a) agreed to the award of contract 6979J Irvine Stewarton (service 113) to Shuttle Buses at a cost of £92,500 for the contract period from 17 July 2016 to 13 July 2019; and
- (b) noted that the award of the contract was subject to satisfaction of the requirements of the mandatory standstill period for EU advertised public sector contracts.

10. Request for subsidised local bus services

After consideration of a report (issued) of 3 May 2016 by the Assistant Chief Executive (Operations) advising members of a request for the provision of a subsidised local bus service to Lincluden Medical Centre, Uddingston, the committee agreed not to take any further action in respect of the request.

11. Community Volunteer Car Schemes in Strathclyde

There was submitted a report (issued) of 15 June 2016 by the Assistant Chief Executive (Operations)

(1) reminding members

- (a) that Community Volunteer Car Schemes (CVCS) provided door to door transport to people in their local community to enable them to access healthcare services, such as doctor and hospital appointments;
- (b) that, although CVCS were Community Transport (CT) services operated primarily by CT operators through local volunteer drivers who made use of their own car, these services were vital to local communities as they provided transport options for vulnerable and older people, those living in rural areas and people with reduced mobility;
- (2) advising members that the demand for these schemes was increasing against the background of an ageing population and recent developments within the Scottish Ambulance Service which was re-focusing their Patient Transport Service to ensure that only eligible patients (i.e. those with a "clinical need") could use the service to access hospital appointments;

- (3) providing information on the development of two key projects which would build on the support currently provided by SPT and assist with overcoming the challenges of better coordination and lack of universal coverage due to geographical gaps or condition based schemes (eg the transport of cancer patients only) together with addressing the questions of funding and sustainability, recruiting/retaining volunteers and meeting increasing demand:
- (4) explaining that a working group was currently being established that would oversee the implementation of a proposal for the development of a community car scheme for cancer patients, including sourcing funding; and
- (5) informing members that SPT continued to lead on the strategic development of CT in Scotland to meet the transport needs of local communities throughout the Strathclyde area.

After consideration and having heard Mr Stewart in answer to members' questions, the committee noted the terms of the report.
