# Minute of the meeting of the Strathclyde Partnership for Transport held via Video Conference at 11am on 12 March 2021

There was submitted a report (issued) of 16 February 2021 by the Assistant Chief Executive advising the Partnership of the receipt of agreement from the Cabinet Secretary for Transport, Infrastructure and Connectivity to the appointment of four new members and the reappointment of two current members.

Members expressed their thanks to outgoing appointed members for their valued contributions, welcomed the newly appointed and reappointed members to SPT and after hearing from Mrs Davidson, the Partnership:

- (i) noted the appointments with effect from 1 April 2021 of the appointed members;
- (ii) noted the committee composition effective from 1 April 2021; and
- (iii) noted the training and briefing sessions planned in support of all members.

# 6. Revenue Budget for 2021/22 – Update

There was submitted a report (issued) of 23 February 2021 by the Assistant Chief Executive recommending the Partnership, following consideration by the Strategy and Programmes Committee, approve a balanced revenue budget for 2021/22 and noting the risks and challenges of preparing a balanced budget during the current period of uncertainty.

This report also highlighted the assumptions being made in the preparation of the budget, proposals for fees and charges and the proposed local authority requisition. In addition, members were asked to approve the amendment to the reserves policy, also as recommended following consideration by the Strategy and Programmes Committee.

After hearing from Mrs Davidson in response to members' questions, and noting that the final Local Government Settlement had been confirmed resulting in a marginal increase of 0.9% to SPTs requisition, the Partnership:

- (i) considered and approved the proposed revenue budget and the assumptions being made, noting the final local authority requisition level will be increased by 0.9%;
- (ii) noted the current and projected reserve balances as detailed in section 5 of the report; and
- (iii) approved the update to the Reserves Policy.

# 7. Proposed Capital Plan 2021/22 to 2023/24 including the Capital Budget 2021/22
