Minute of the meeting of the Strathclyde Partnership for Transport's Operations Committee held in Consort House, Glasgow, on 5 November 2010

1. Declaration of interest

2. Minute of previous meeting

3. Public transport services monitoring report

There was submitted a report (issued) of 28 October 2010 by the Assistant Chief Executive (Operations)

- (1) informing the committee of the latest trends in the number of passengers carried and the reliability of services directly operated and supported by the Partnership and on ScotRail services in the SPT area; and
- (2) providing information on the current status of SPT's six point bus action plan for the continuing improvement of bus service delivery within the region, together with regulating and fleet profile statistics.

After discussion and having heard Mr Stewart in answer to members' questions, the committee noted the contents of the report.

4. Competition Commission decision on the relaxation of ScotRail undertakings <u>Click here to view report</u>

There was submitted and noted a report (issued) of 28 October 2010 by the Assistant Chief Executive (Operations)

- (1) informing members that on 15 October 2004 the Competition Commission had accepted certain undertakings given by First Group plc with regard to the proposed acquisition of the Scottish Passenger Rail (ScotRail) franchise which had included a restriction on altering service levels and fares on certain bus routes (the controlled routes) for the duration of the rail franchise, ie until 2014;
- (2) advising members of the outcome of a recent review by the Competition Commission of a request by FirstGroup for a relaxation of those undertakings, in order that they could withdraw seven of the controlled routes and modify certain others; and
- (3) explaining that, despite representations from SPT expressing the concern of the Partnership that the relaxation of the undertakings was likely to require unanticipated additional funding to maintain essential social transport links, the Competition Commission had concluded that, by reason of the change of circumstances, it was appropriate to vary the undertakings to allow FirstGroup to make the proposed withdrawals and proposed modifications to the services detailed in the report.

5. Subsidised local bus service contract recommendations – financial implications <u>Click here to view report</u>

6. Paisley Statutory Quality Partnership Scheme

With reference to the minute of the Partnership of 11 June 2010 (page 4, paragraph 6) when the Partnership had

- (1) considered a report on the Statutory Quality Partnership Scheme which had been introduced by the Scottish Parliament under the Transport (Scotland) Act 2001 as the preferred mechanism to improve the quality of bus service provision; and
- (2) approved the formation of a Statutory Quality Bus Partnership jointly with Renfrewshire Council for Paisley Town Centre,

there was submitted and noted a report (issued) of 28 October 2010 by the Assistant Chief Executive (Operations)

(a) intimating

5 November 2010

- (i) that following new guidelines issued by the Scottish Government for the introduction of Quality Bus Partnership Schemes, Renfrewshire Council had decided to defer the introduction of the proposed scheme to permit consideration of these guidelines and ensure that the processes previously undertaken complied with those suggested; and
- (ii) that the opportunity had been taken also to consider further additional submissions made by bus operators in belated response to the earlier consultation;
- (b) advising members that, as a result of this review, some changes had been made to the proposals and a further, short consultation exercise was currently being undertaken with a view to introducing the Quality Partnership in March 2011;
- (c) summarising the changes which had been made to the proposals; and
- (d) informing members that, having agreed the changes in principle and delegated officers to finalise proposals following the consultation, which had ended on 27 October, Renfrewshire Council would formalise these revised arrangements at their first available committee meeting scheduled for 17 November 2010.

 - Create Ltd CamGlen NHS Car Sharing Project ;
 - Getting Better Together Community centred health initiative in the Greater Shotts and surrounding areas;
 - Glasgow City Council hospital evening visitor service;
 - North Area Transport Association Community transport services in North Glasgow; and
 - Stepping Stones for Families Travel Connections Girvan and Maybole schemes; and
- (3) appending a table detailing the amount of grant funding awarded to each of the projects.

- (2) agreed that a report on the conference would be submitted to a future committee,

there was submitted a report (issued) of 26 October 2010 by the Assistant Chief Executive (Business Support)

- (a) advising members that the conference had consisted of a series of panel 'question and answer' sessions and had focused on the following key themes:-
 - Maritime;
 - Land Freight;
 - Land Passenger; and
 - Public sector;
- (b) appending a summary of research into business attitudes to transport and the provision of key statistics and trends on transport in Glasgow and the west of Scotland which had been prepared by SPT for the conference;
- (c) highlighting that the conference had been successful in stimulating debate amongst the private sector as to what their priorities for transport were currently and in the future; and
- (d) explaining
 - (i) that Glasgow Chamber of Commerce was compiling a note of the key outcomes of the conference, with a view to preparing a 'Business Priorities for Transport' document later in the year; and

(ii) that SPT officers would continue to liaise with Glasgow Chamber of Commerce and provide assistance where necessary.
