If you have changed address, please provide proof of your new address. These documents (current or within last three months) are examples of acceptable proof of address:

- Home Utility Bill (e.g. Gas, Electricity, Land Line Telephone) or television licence
- Council Tax Bill (current financial year)
- Bank, Credit Card, Mortgage or Occupational Pension Statement

Please note – to qualify for a Companion Card you must be:

- In receipt of DLA higher/middle rate of care component;
- In receipt of PIP standard/enhanced rate of daily living component
- In receipt of Attendance Allowance; or
- Eligible for the above and receiving nursing care in a care home or hospital.

Documents should be copies unless otherwise specified. We cannot return originals.

Documents must include name and address and be dated within the past 12 months.

Disability Living Allowance (DLA) - higher rate of mobility or higher/middle rate of care component **Required: Award letter from DWP, stating the rate and length of the award.**

Attendance Allowance

Required: Award letter from DWP, stating the rate and length of the award.

Personal Independence Payment (PIP) – standard/enhanced rate of mobility or standard/enhanced rate of daily living component

Required: Award letter from DWP, stating the rate and length of the award.

Living and receiving nursing care in a care home or hospital and eligible for higher/middle rate of care component of DLA, PIP or Attendance Allowance

Required: DLA/PIP/AA award Letter as above, or if benefit suspended we can consider a letter from the hospital/care home confirming that you live there and receive 24-hour nursing care.

Blue Badge holder

Required: Valid Blue Badge (photocopy of both sides), V11 reminder from DVLA showing the "disabled" classification or exemption certificate DLA404 or WPA0442 from the DWP.

Profoundly or severely deaf

Required: Letter from Audiologist, Hospital Consultant or Registered Society for the Deaf confirming bilateral hearing loss greater than or equal to 70dBHLs averaged over 1, 2 and 4KHz, or a letter from your GP confirming that you have been profoundly or severely deaf since birth.

Driving licence refused or revoked on medical grounds

Required: Letter from DVLA, showing that licence has been refused or revoked on medical grounds OR original NCT003 (certificate of eligibility – epilepsy) signed by a Hospital Consultant, General Practitioner or Epilepsy Specialist Nurse. (NCT003 certificate available from TCU, address overleaf).

Mental health condition recognised under the Mental Health (Care and Treatment) (Scotland) Act 2003, which has lasted for more than a year and impairs your ability to travel. You must need to travel to health or social care appointments as part of treatment activities, care or a rehabilitation programme

Required: Original, authorised NCT002 form (Mental Health Certificate) available from mental health clinic, hospital or centre providing the programme.

Learning disability recognised under the Mental Health (Care and Treatment) (Scotland) Act 2003, and the need to travel to see a Support Worker or get to appointments or activities as part of ongoing support, care or treatment

Required: Original, authorised NCT002a form completed by someone who is co-ordinating or involved in the programme, such as a Support Worker, Social Worker or Local Area Co-Ordinator.

Terminal illness or progressive, degenerative condition that severely impedes mobility and the ability to carry out day-to-day activities

Required: DS1500 report, hospice admittance letter, confirmation of registration on Scottish Hospice Register, letter from a Hospital Consultant (or other specialist medical professional providing any treatment and support) clearly stating what the condition is and confirming that it is progressively degenerative and severely impedes mobility and your ability to carry out day-to-day activities.

Loss of limbs (one/both legs or both arms)

Required: Written confirmation from prosthetics clinic or physiotherapist.

Armed Forces Compensation Scheme or lump sum benefit within tariff levels 1-8 (inclusive) or War Pension with mobility supplement/War Pension with constant attendance allowance **Required: Certification letter from the Service Personnel and Veterans Agency or award letter from Veterans' Agency or MoD.**

Registered blind or partially sighted Required: Photocopy of official Local Authority Blind or Partially Sighted registration certificate.
