There was submitted a report (issued) of 12 September 2022 by the Treasurer providing the Committee with the '2021/22 Annual Audit Report to members of the Strathclyde Concessionary Travel Scheme Joint Committee and the Controller of Audit' produced by the appointed external auditor Azets.

After hearing from Ms Jones of Azets in response to members' questions, and highlighting that the report:

- (i) confirmed an unqualified audit certificate had been issued;
- (ii) noted the external auditor had been supplied with high quality supporting documents in the course of their work; and
- (iii) confirmed that in the view of the external auditor appropriate arrangements were in place to manage the medium to long term financial position.

The Committee noted the finalised '2021/22 Annual Audit Report to members of the Strathclyde Concessionary Travel Scheme Joint Committee and the Controller of Audit'.

Thereafter Mr Wylie expressed his thanks to both the corporate finance team and Azets for the work done, noting that this was the final year of appointment for Azets.

There was submitted a report (issued) of 12 September 2022 by the Treasurer advising members of:

- (i) the final outturn for the financial year 2021/2022; and
- (ii) the revenue expenditure incurred at the end of Period 5 (20 August 2022), together with the projected outturn to the end of the current financial year.

After discussion and hearing from Mr Paul, Mrs Davidson, Mr Breen and Mr Wylie in answer to members' questions, specifically relating to the level of reserves, the Chair noted given the complimentary nature of the matters under consideration, the importance of the SPT Partnership being aware of the Joint Committee's work. Thereafter, the Committee approved:

- (i) the circulation of previous reports into the fare structure for the local scheme:
- (ii) the final outturn position for 2021/2022;
- (iii) the projected outturn position for 2022/2023 based on the information available at the end of P5; and
- (iv) the implementation of the new fare structure will be considered in the Proposed Revenue Budget 2023/2024 paper going to the next Joint Committee, and would take account of the ongoing cost of living pressures as well as the level of available reserves.

There was submitted a report (issued) of 21 September 2022 by the Treasurer updating the Committee on the Strathclyde Concessionary Travel Scheme's performance and reimbursement results for 2021/2022 financial year-end and for 2022/2023 Quarter 1 (April-June).

After hearing from Mr Breen in answer to members' questions, the Committee noted the contents of the paper and in particular the continued impact of Covid-19 on the patronage levels, and the potential impact of cost of living pressures on concessionary travel demand and on operator reimbursement costs.

- (ii) noted the ongoing work between SPT and ScotRail to seek ticketing enhancements.

After hearing from Mr Wylie in answer to members' questions the Committee:

- (i) noted the contents of the report and agreed more specific KPI information would be developed for future reports;
- (ii) noted the progress made with digital enhancements, recognising that arrangements must be in place to ensure those unfamiliar or unable to use technology were not disadvantaged;
- (iii) welcomed further future integration to improve the service further; and
- (iv) welcomed the development of support to local authorities following the 'Under 22 concession bus' marketing national campaign.
