# Minute of the meeting of the Strathclyde Partnership for Transport held at 131 St Vincent Street, Glasgow and via Video Conference\* at 10am on 16 December 2022

There was submitted a report (issued) of 25 November 2022 by the Chief Executive/Partnership Secretary providing the Partnership with an update on membership changes since the last Partnership meeting of 30 September 2022.

After hearing from Mrs Davidson in response to members' questions, the Partnership noted:

- (i) the change of membership from West Dunbartonshire Council;
- (ii) that a further update from North Lanarkshire Council had been received following the issue of the papers advising that Cllr Smith was replacing Cllr Keltie; and
- (iii) the updated Committee Representation document.

After hearing from Mrs Davidson in response to members' questions, the Partnership approved the amendment to Paragraph 2.5.1 of the Partnership Standing Orders will stand adjourned without discussion to the next meeting of the Partnership on 17 March 2023, and following any relevant comments received, will be submitted to the next Partnership meeting for approval.

# 7. Regional Transport Strategy – Public Consultation – Initial Summary Findings and Recommended Actions

There was submitted a report (issued) of 24 November 2022 by the Chief Executive updating the Partnership on the initial summary findings of the recently completed consultation on the Draft Regional Transport Strategy (RTS) and recommending approval of actions as a result of the consultation.

After discussion and hearing from Mrs Davidson and Mr Dickson in response to members' questions, particularly on the Fair Fares Review being conducted by Transport Scotland, and providing a further clarification to that contained within the report that an RTS Action Plan will address how SPT aim to deliver on all RTS objectives, the Partnership:

- (i) noted the initial summary findings of the Draft RTS public consultation;
- (ii) consideration would be given to whether affordability of public transport should include "for all", and inclusion of a public transport guarantee was appropriate; and
- (iii) approved the recommended actions in Section 4 for taking forward for the development of the Final Draft RTS, which will be presented for approval to the Partnership meeting on 17 March 2023.

#### 8. Subway Modernisation – progress update

There was submitted a report (issued) of 23 November 2022 by the Director of Subway providing the Partnership with the latest progress update on the Subway Modernisation programme.

After hearing from Mr Smith, the Partnership noted:

- (i) the continued progress made on all Subway Modernisation and improvements works since the last written update to the Partnership in June 2022;
- (ii) ongoing progress on the MSA contract including the commencement of in-tunnel train unit testing, and also on the existing signalling;
- (iii) the continued challenge towards performance improvement on the TSSSA contract;
- (iv) progress made on operational readiness and delay mitigation actions including existing infrastructure and fleet maintenance improvements;
- (v) that the modernisation programme remains within overall budget and funding; and
- (vi) that a further report on progress will be presented to the Partnership meeting on 23 June 2023.

Thereafter, the Chair expressed his thanks to SPT staff for their continued work on the modernisation project.

#### 9. Subway Patronage, Revenue and Fares: Update

There was submitted a report (issued) of 30 November 2022 by the Director of Finance & Corporate Support:

- (i) providing members with an update on the strong recovery of Subway patronage following the Covid 19 pandemic;
- (ii) recommending approval of the postponement of the previously proposed Subway fare increase in January 2023; and
- (iii) informing the Partnership that a future Subway fare increase will be considered within the context of 2023/2034 SPT revenue budget considerations.

After hearing from Mr Wylie and Mrs Davidson in response to members' questions and hearing that the proposal affected users from a much wider area than just Glasgow, and the issue of access to data for sound transport planning would be raised with the Transport Minister in January 2023, the Partnership:

- (i) noted the strong recovery of Subway patronage;
- (ii) approved the postponement of the previously proposed Subway fare increase in January 2023 and noted that this be considered further as part of the 2023/2024 budget deliberations; and
- (iii) noted that SPT will continue to engage with Transport Scotland and other partners regarding inclusion of Subway in the Young Persons' Free Bus Travel Scheme.

After hearing from Mr Wylie and Mrs Davidson in response to members' questions on marketing of the Subway, the Partnership approved the extension of the current media buying contract for the provision of these services to The Media Shop for the period of up to August 2023 and at SPT's discretion, subject to performance and available funding, to a maximum of £70k.
