Travel Card Unit Update Performance and Key Issues

1. Object of Report

The object of this report is to update the Joint Committee on the performance of the Travel Card Unit (TCU) and provide updates on any other activities affecting the Travel Card Unit.

2. Background

SPT's Travel Card Unit, based at Buchanan Bus Station (BBS), is responsible for administering the National Entitlement Card on behalf of the 12 SCTS-area local authorities. Contact with cardholders and applicants from the 12 LAs takes the form of email, postal correspondence, faxes, telephone calls and face-to-face enquiries at the Concessionary Travel Booth in BBS.

3. Cards in Circulation

As at May 2017 there were 545,713 valid cards in circulation within the SCTS area, up from 537,847 in January of this year, an increase of 1.46% (Appendix A). This is, however, a reduction from October 2016 when 547,942 cards were in circulation. This may be attributable to the card renewal programme (see "NEC Migration Project", below) which involved a data cleansing exercise to identify and withdraw duplicate cards.

4. NEC Migration Project


The migration of the NEC estate from OneScotland (CMD7) cards to mygovscot and SaltireCard (CMD2) is now complete, although some enquiries continue to be received from cardholders whose data was not matched and therefore did not receive a replacement card during the migration project.

5. TCU Performance

Call Volumes

Call volumes have returned to manageable levels following a surge in queries towards the completion of the card migration programme.




Cumulative figures for previous three years are:

Call Handling

Call handling rates fell below target of 95% in three of the thirteen periods, mainly due to extremely high call rates during the card replacement programme:

6. Developments within Travel Card Unit

SPT is currently reviewing processes within the TCU to ensure that the department is equipped to cope with increasing numbers of card holders and the resultant uplift in contact from NEC holders.

As organisations prepare for the introduction of GDPR regulations in May 2018, SPT is engaged with the National Entitlement Card Programme Office (NECPO) and our local authority partners to ensure compliance.

7. Committee Action

The Committee is recommended to note:

- The progress of the Travel Card Unit in supporting concession travel on behalf of the 12 councils in the Scheme area and the work being undertaken as part of their card issue; and
- The completion of the card migration programme.
