Minute of the meeting of Strathclyde Partnership for Transport's Strategy & Programmes Committee held at 131 St Vincent Street and via Video Conference* on 9 June 2023

The minute of the meeting of 17 February 2023, having been considered and approved at the Partnership meeting on 17 March 2023 as a correct record, was duly noted.

4. Proposed Capital Amendments 2023/2024

There was submitted and discussed a report (issued) of 17 May 2023 by the Director of Finance & Corporate Support seeking approval for proposed amendments to the 2023/2024 capital programme and seeking approval to Grant Fund as detailed in section 6 of the report.

After considerable discussion, specifically highlighting that resources are being directed to Partnership priorities and after hearing from Mr Wylie and Mr Kiloh in response to members' questions and noting the additional funding in support of active travel, the Committee:

- (i) approved the proposed amendments to the 2023/2024 capital programme as per Appendix 1 of the report;
- (ii) agreed to Grant Fund or to vary existing Grant Fund letters to the Local Authorities or other bodies for those awards up to the value of £200,000 and authorise that grant award letters be concluded in line with approved governance arrangements;
- (iii) agreed to recommend to the Partnership meeting of 23 June 2023 approval to Grant Fund or to vary existing Grant Fund letters to the Local Authorities or other bodies for those awards over a cumulative value of £200,000; and
- (iv) noted that further work to quantify and manage risk, advance savings and re-phase existing projects is being undertaken to balance spend against budget.

After hearing from Mr Kiloh and Mrs Davidson, particularly on moving forward on early work on projects that would support the wider ambition of Clyde Metro and the work being done by SPT and partners to support advancement of the case for investment as early as possible, the Committee noted the report.

After extensive discussion, particularly on seeking more information on whether further improvement on public transport accessibility was being considered and:

- (i) the expected timescales of Transport Scotland to issue the necessary guidance and enabling regulations of the Transport Scotland Act;
- (ii) whether SPT was seeking to engage with and exploring opportunities for additional funding, including that available via The Scottish Zero Emission Bus Challenge Fund (Scotzeb);
- (iii) how SPT was ensuring a consistency with the National Planning Framework;

and after hearing from Mr Kiloh, Mr Wylie and Mr Dickson in response to members' questions, the Committee noted the report, and agreed that a briefing note outlining more information on the Highland Council school / local bus project should be circulated to all members.

After discussion with members welcoming this next step and hearing from Mr Dickson and Mr Kiloh in response to specific questions, the Committee:

- (i) approved the award of contract for consultancy support to develop the Strathclyde Regional Bus Strategy to Systra Limited for a value of £147,188 (excluding VAT);
- (ii) noted that Work Packages 3 6 will be awarded at SPT's discretion and Partnership approval, and will be dependent on the outcomes of Work Packages 1 and 2; and
- (iii) following (ii) above, noted that the programme and costs for Work Packages 3-6 will be subject to approval by a future Committee at the appropriate time.
